1. By Completing this form, you are hereby notified that this is an application and does not guarantee that you will qualify or be allocated a catering spot at the event.
2. All successful applicants will be notified in writing by the 2nd of August 2024 and a concession agreement with the terms and conditions for the event will be sent to the successful applicants. Should you not adhere to the terms and conditions, you will be disqualified and will have no further participation at the event.
3. On the days of the event, strict statutory regulations, and venue compliance and all OHS Hygiene processes will need to be followed. Failure to maintain a satisfactory level of hygiene you will result in no further participation on at the event.
4. All applications need to be submitted by 25th July 2024.
5. Successful applicants will be notified on the 2nd of August and will be requested to make a non-refundable ,25% deposit by the 6th of August 2024.
6. Full and final payment will be required by the 9th of September 2024.
7. Failure to make payment will result in non-participation.
8. Mandatory Training and briefing session will be held on the 14th of August from 10h00 till 14h00 at Waterkloof venue TBC.
9. Vendor space allocation will be 3m frontage x 6m deep.
10. Approved vendors will need to be setup and be event ready by 15h00 on the 16th September 2024.
11. Main Event Catering will supply grey water drainage points and a communal hand wash facility.
12. No personal Generators or Open Flame cooking are permitted on site.
13. All Vendors need to comply with City of Tshwane, Airforce Base Waterkloof, OHS and Military By-laws and regulations at all times.
14. Only one (1) x 9kg Gas Cylinders allowed per 3m vendor space. All Gas Cylinder need to be purchased from the onsite gas vendor from the central stores as to comply with handling and storage regulations.
15. Vendors may not bring in their own gas cylinders.



16. Accreditation will need to be completed by each approved vendor. Only fully paid vendors will receive the email link to complete online accreditation. Only 5 Staff members per space allocation.
